4th Resolution for the Supervisor, Motion made by Corey, 2nd by Kara, All in Favor, Motion Passed (12100.00)

Regarding the Clerk for each election the Clerk will get a bonus of \$600.00. The Election Workers and Chair Person will get a \$3.00 an hour raise. Election Workers going from \$15.00 to \$18.00. Chair Person will go from \$18.00 to \$21.00 an hour.

These increases will go into effect starting April 1, 2023.

March 14, 2023 will be the Township Annual Meeting.
