Motion made by Corey, 2nd by Brett to approve the minutes from the October Meeting.

Heather Hoffman came to our meeting to go over the Poverty Exemption. Heather went over the Resolution and explained & answered questions. There were a few items that needed to be changed. Bob made a motion to accept the Resolution once the changes are updated. This was 2nd by Tayloe, All In Favor, Motion Passed.

The Board was polled. Bob yes, Taylor yes, Brett yes, Tami no, & Corey no. 3 to 2. Motion Passed
